It is important to adopt a non emotional approach to research. One should be completely neutral while discussing one's favorite and dislike writers, poets, critics and intellectuals. The importance of curiosity in the characteristics of the researcher cannot be denied. Curiosity in the form of a stimulus determines the researcher's action from moment to moment. Professor Abdulsitar Ridolvi writes:

AbdulRazzaq Qureshi writes:

It is important to represent the literary taste in the style of writing and presentation of the researcher. Consistency is important in the content and arguments presented by researcher and it is also important to keep in mind the continuity under the topic. It is important to complete the research paper within the specified time frame otherwise the time lapse as well as the scholar's dishonesty are prominently exposed. Consistency in research topic and its sub-topics is also important and unnecessary interpretations should always be avoided. Researcher should show his/her research paper to the supervisor before going through the final stages so that no errors remain. Instead of a pile of incidents and references, a suitable selection of them should be presented. In encyclopedia Britannica research is a careful study:
